



# Directions to the Quality Inn Appalachian Conference Center

From Charlotte, NC Airport: Leaving the airport take I85 south to the highway 321 north exit (in Gastonia) and follow through Hickory, Lenoir, Blowing Rock and into Boone.

Coming into town on 321 north: Pass Tweetsie Railroad on the left and into Boone, go through the 6th stop light (321/105 intersection) and the hotel is on the immediate right.

From Raleigh or Greensboro, NC: Take I40 west to 421 north (in Winston Salem) and follow through Wilksboro into Boone.

Coming into town on 421 north: Pass the Nissan Dealership on the left and go to the 5th stoplight and turn left onto 105 extension then go to the 2nd stoplight and the hotel is on the right (105/321 intersection - do not go through the light).
